STEP 1 ➤ APPLICATION

Type or print your social security number.*

Type or print your name exactly as you intend to sign documents as a notary public. You do not need to use your full name. Examples of suffix include: Jr., Sr., III, etc.

Mailing address can be your home or business address.

Enter your email address for your commission and oath to be delivered electronically from the Secretary of State.

If you do not have a Texas Driver's License, type or print the number of your Texas ID Card or the number from your other state issued ID.


As a reminder, if you have been found guilty of a crime, you must submit proper documentation to assist the Secretary of State's Notary Unit in determining qualification. PLEASE NOTE: the processing time is approximately 4-6 weeks.

BOND

Leave this section blank. We will complete your bond and deliver it to the Secretary of State for processing.

STATEMENT OF OFFICER

Date and sign the **Statement of Officer** at the RED (X) exactly as name appears above. **DO NOT HAVE THIS FORM NOTARIZED.**



*The disclosure of your social security number is mandatory. Its solicitation is authorized by Chapter 406 of the Government Code and is used to maintain accuracy of the notary records.


